
Declaration of Rick W. Griffin

I, Rick W. Griffin, President and Chief Executive Officer of CareSouth Health System, Inc., a Delaware corporation, located at One Tenth Street, Suite 500, Augusta, GA 30901-0103, am authorized to make this Declaration in my present capacity as President and Chief Executive Officer of CareSouth Health System, Inc.

1. I am making this Declaration in connection with Service Mark Registration No. 2154810 for the mark CARESOUTH.
2. On January 4, 1999 I was Executive Vice President & General Counsel of CareSouth Home Health Services, Inc., a Georgia corporation, with personal knowledge of the facts herein.
3. Specifically, the Assignment between CareSouth Home Health Services, Inc., a Georgia corporation, and CareSouth Health System, Inc., a Delaware corporation, dated January 4, 1999 and recorded with the Assignment Division of the United States Trademark Office on April 13, 1999 at Reel 1888, Frame 0141 for Service Mark Registration No. 2154810, contains an inadvertent error with respect to the "effective nunc pro tunc date."
4. The effective nunc pro tunc date of "March 1, 1998" in said document was in error and should have been stated as "March 10, 1998."
5. In addition, the cover sheet that accompanied the Assignment between CareSouth Home Health Services, Inc., a Georgia corporation, and CareSouth Health System, Inc., a Delaware corporation, dated January 4, 1999 and recorded with the Assignment Division of the United States Trademark Office on April 13, 1999 at Reel 1888, Frame 0141, contained a typographical error with respect to the spelling of Assignee's name. The Assignee's name is stated on said cover sheet as CareSouth Health Systems, Inc. whereas the Assignee's name should have been stated as CareSouth Health System, Inc. without the "s" on the word "System" as per the underlying January 4, 1999 Assignment document.
