## RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of **March 31, 2008** (this "Release") is made by U.S. Bank National Association, a National Association, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain Security Agreement, dated as of **April 13, 2006** and recorded in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among **J.G.B. 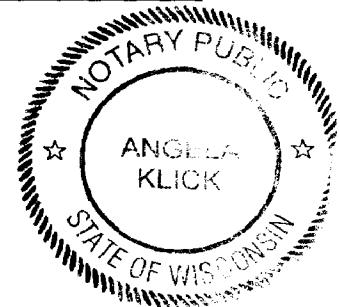
