**TRADEMARK ASSIGNMENT And LICENSE (INTERNATIONAL TO INNOVATIONS)**

This TRADEMARK ASSIGNMENT and LICENSE (the "Assignment/License") is effective as of February 3, 2008 (the "Effective Date"), by and among ELLMAN INTERNATIONAL, INC., a New York corporation having a place of business at 3333 Royal Ave., Oceanside, New York ("Assignor/Licensor") and ELLMAN INNOVATIONS, LLC., a limited liability company having a place of business at 3333 Royal Ave., Oceanside, New York ("Assignee/Licensee").

WHEREAS, Assignor/Licensor is the owner of all right, title and interest in and to the trademarks listed in Schedule A, Schedule B, and Schedule C hereto; and

Assignee/Licensee is desirous of acquiring the Schedule A trademarks together with that part of the good will of the business in which the mark is used, as well as licensing the Schedule B and Schedule C trademarks for use in its business, and

Assignor/Licensor has agreed to assign, transfer and convey to Assignee/Licensee all of their right, title and interest in and to the Schedule A trademarks together with the good will associated therewith to Assignee/Licensee, as well as to license the Schedule B and Schedule C trademarks to Assignee/Licensee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor/Licensor and Assignee/Licensee hereby agree as follows:

- a. Assignor/Licensor hereby sells, assigns, transfers, conveys and delivers to Assignee/Licensee, its successors, assigns or other legal representatives, all of their right, title and interest in and to the trademarks, including all applications and registrations therefore, listed in Schedule A, together with that part of the goodwill of the business in connection with which the Schedule A marks are used, and including the subject matter of all claims which may be obtained therefrom, together with all claims for damages by reason of past, present or future infringement or other unauthorized use of such marks, with the right to sue for, and collect the same.
- b. Assignor/Licensor hereby authorizes Assignee/Licensee to request the relevant government entity or agency to record Assignee/Licensee as the assignee and owner of the entire right, title and interest in and to each of the Schedule A marks, for the sole use and enjoyment of Assignee/Licensee, its successors, assigns and other legal representatives.
- c. Assignor/Licensor hereby grants to Assignee/Licensee a paid-up, perpetual, royalty-free, non-exclusive license to use, display and make reference to the Schedule B and Schedule C marks only for use in connection with the Assignee/Licensee's business.
- d. Recognizing the great value of the goodwill associated with the Schedule B and Schedule C marks and the identification of Assignor/Licensor with those marks, Assignee/Licensee and Assignor/Licensor agree that (i) Assignor/Licensor reserves the right to control the nature and quality of the

goods in connection with which the Schedule B and Schedule C marks are used by Assignee/Licensee, and to control the form and manner in which such marks are used, (ii) all goodwill arising from Assignee/Licensee's use of the Schedule B and Schedule C marks will inure solely to the benefit of Assignor/Licensor, and (iii) Assignee/Licensee will not challenge or assist others to challenge the rights of Assignor/Licensor in the Schedule B and Schedule C marks or their registration, or attempt to register any trademarks, service marks, domain names, trade dress, logos, trade names, and corporate names or other proprietary indicia confusingly similar to the Schedule B and Schedule C marks.




