ORDER APPROVING SALE OF ASSET

THIS MATTER comes before this Court upon the Motion by Kevin Campbell, the duly appointed and acting Chapter 7 Trustee for the above Debtor, seeking to sell the Estate's interest in certain equipment and other property free and clear of liens and interest. The property is more fully described on the attached Exhibit "A". The Trustee desires to sell the assets to Marine.com, or its assigns. The purchaser does not have any known adverse interest to this case or any parties involved in the case. The sales price is \$50,000.00 payable in cash or certified funds.

This property is being sold in "as is" condition, without any warranties whatsoever, and specifically excludes any implied warranty or merchantability and any implied warranty of fitness for a particular purpose. The purchaser agrees to receive this property with all faults.

The Trustee has informed the Court that all parties in interest have been notified of his intention to sell said property, and that no objection to the proposed sale has been received by him or filed by any party in the Office of the Clerk of this Court. The Trustee has represented to the Court that such sale is in the best interest of creditors of the estate. The Trustee is further informed and believes that there are no perfected liens of record against this property. A disputed secured creditor has stipulated that it failed to properly perfect its security interest as required by the Uniform Commercial Code and that no formal action was required by the Trustee to contest this disputed lien.

I find that all creditors and parties in interest were properly served with the notice of this sale, and that no objections were filed with this Court or served on the Trustee;

I find that the sale of this property by private sale is in the best interest of the estate and its creditors;

I find that Fed.R.Bankr.P. 6004(g) is hereby waived in this matter and that the Trustee be allowed to immediately enforce and implement this Order; it is, therefore

ORDERED that the Trustee's Motion to sell property free and clear of all liens is hereby approved and the Trustee is authorized to sell and convey the Estate's interest in the above-described property on the terms and conditions set forth herein;

IT IS FURTHER ORDERED that the Trustee is authorized to sign any and all documents necessary to effectuate the sale/transfer of this property;

3. All domain names, all contact lists, all email lists, all sailing articles of the Sailnet Community.
4. All Computer hardware and accessories, cables, etc (includes 3 routers, 4 switches, 2 hubs, 2 Dell 6400 poweredges, 2 Dell 2400 power edges, 12 P4 Clone Servers, 2 F5 Loadbalancers, 2 p4 web servers, 2 xeon db servers, 1 lyris p4 server.
5. All software and software licenses.
6. Rights to contractual relationships of approximately 30 hosted sites.
7. Pictures and Graphics - All digital pictures and graphics.
8. All logos, letterhead, graphics, web site designs and other Sailnet identifying symbols and signs related to the rights of Sailnet to its brands.
9. All Sailnet trademarks and copyrights as well as all other legal rights to IP assets.
10. All other IP assets, contractual rights, licenses, agreements etc used by Sailnet in the operation of the Sailnet business including the management and operation of the "Sailnet Community" and the affiliates, business partners, forums, etc.
