THIRD: The Company is continuing its existence in the organizational form of a Utah limited liability company. The name of the Utah limited liability company into which the Company is converting is **ELDORADO STONE OPERATIONS, LLC**.

FOURTH: The conversion of the Company into the Utah LLC shall be effective upon the filing of these Articles of Conversion and the Articles of Organization for the Utah LLC, which are filed contemporaneous with these Articles of Conversion



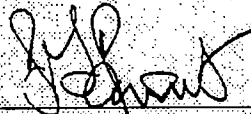

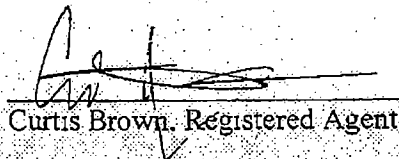
