BILL OF SALE AND ASSIGNMENT

BILL OF SALE and ASSIGNMENT, dated as of June 8, 2001, from **VICTORIA AND RICHARD MACKENZIE-CHILDS, LTD.**, a New York corporation whose address is 3260 State Route 90, Aurora, New York 13026 (the "Seller") to **MCL ACQUISITION CORPORATION**, Delaware corporations whose address is c/o Vogel Consulting Group, S.C., 3415 Gateway Road, Brookfield, Wisconsin 53045 (the "Purchaser").

WHEREAS, by a certain Asset Purchase Agreement dated as of April 26, 2001, as amended by a First Amendment to Asset Purchase Agreement dated as of May 21, 2001, as approved by Order of the Bankruptcy Court dated June 8, 2001, by and among Seller and Purchaser (the "Asset Purchase Agreement"), Seller agreed to transfer, sell, convey, release, assign and deliver to Purchaser, and Purchaser agreed to purchase substantially all of the operating assets of Seller except the assets excluded pursuant to Section 1.2 of the Asset Purchase Agreement (such assets to be acquired sometimes being referred to as the "Assets");

WHEREAS, pursuant to the terms of the Asset Purchase Agreement, Seller has made certain representations, warranties and covenants concerning various matters, including, but not limited to, the Assets, Seller's performance under the Asset Purchase Agreement, and the conduct of Seller's business ("Seller's Warranties");

WHEREAS, Seller is executing and delivering this Bill of Sale and Assignment to Purchaser for the purpose of transferring, selling, conveying, releasing, assigning and delivering to, and vesting in, Purchaser the Assets; and

WHEREAS, simultaneously, with such sale and pursuant to due authorization, Purchaser has paid the purchase price contemplated by Section 2.1 of the Asset Purchase Agreement.

NOW, THEREFORE, in consideration of the premises and of the purchase price and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Seller by these presents does, except to the extent excluded herein or pursuant to Section 1.2 of the Asset Purchase Agreement, bargain and sell, transfer, convey, release, assign and deliver to, and vest in Purchaser all of the assets, properties and rights tangible and intangible, real, personal or mixed owned by Seller as of the date hereof wherever located, whether known or unknown and whether or not on the books of Seller and, to the extent assignable and in accordance with Section 1.1 of the Asset Purchase Agreement, all of Seller's rights under all agreements, contracts, licenses, leases, documents and other contracts to which Seller is a party as of the date hereof, including without limitation the following, as more particularly identified, in Schedule 1.1(f) of the Asset Purchase Agreement:

- (a) All inventories of whatever kind, including, without limitation, finished goods, work-in-process and raw materials, socks, and all packaging and shipping inventory (the "Inventories");
- (b) All trade and other accounts receivable, all notes receivable and all other amounts receivable (except receivables owing from MacKenzie-Childs of California, Ltd. and MacKenzie-Childs of Canada, Ltd.) (the "Receivables");
- (c) All current assets (not including cash and cash equivalents);
- (d) All prepaid expenses, advance payments and deposits (the "Prepaid Expenses");
- (e) All equipment (building or office), machinery, tooling, dies, molds, patterns, stampings, prototypes, parts, components, projects in process, furniture, antiques, artwork, fixtures, tools, related spare parts and supplies, manuals, written warranties or other similar documents related thereto and

fixed assets, including, without limitation, those items listed on Schedule L.1(e) attached hereto (the "Equipment");

- (f) All rights of the Seller pursuant to the contracts, agreements, leases and similar obligations listed on Schedule L.1(f) (the "Contracts");
- (g) All governmental and non-governmental licenses, permits, authorizations, certifications, accreditations, consents and indulgences;
- (h) All manufacturing, delivery, office and other supplies;
- (i) All Intellectual Property (including, without limitation, all Intellectual Property listed on Schedule L.1(i)) and all goodwill associated with the foregoing, all goodwill associated with respect thereto, licenses and sublicenses granted and obtained with respect thereto and rights thereunder, remedies against infringements thereof and rights to protection of interests therein under the laws of all jurisdictions;
- (j) All warranty rights, guaranty rights, causes of actions, judgments and claims and similar rights of the Seller against vendors, suppliers, designers, architects, engineers or other third parties;
- (k) All leasehold interest in real property;
- (l) All livestock, animals (including the young of all livestock and animals), crops, livestock feed, farm supplies and farm products;
- (m) All rights pursuant to the license agreement with Momeni, Inc., Paper Products designed U.S. Inc. (including, but not limited to, the Henny Penny Product/Design) and Dal-Tile Corporation;
- (n) All business and personnel records and documents of the Seller;
- (o) All unemployment compensation account balances;
- (p) All cash surrender value of life insurance owned by the Seller; and
- (q) All causes of action, choses in action and rights of recovery with respect to any of the foregoing.

All of the above, except as relating to the retail store owned and operated by MacKenzie-Childs of New York, Ltd.

TO HAVE AND TO HOLD all the Assets unto Purchaser, its successors and assigns, to its own use and benefit forever, and Seller does for itself, its successors and assigns, covenant and agree with Purchaser to WARRANT AND DEFEND the sale of the Assets against all and every person and person whomsoever.

Section 1. Seller hereby constitutes and appoints Purchaser, its successors and assigns, as the true and lawful attorney and attorney of Seller with full power of substitution in the name and stead of Seller, but on behalf and for the benefit of Purchaser, its successor and assigns, to demand and receive any and all of the assets, properties and rights assigned or to be assigned to Purchaser pursuant to the Asset Purchase Agreement and to give receipts and releases for and in respect to the same or any part thereof, to endorse any claim or right of any kind in respect thereof and to do all acts and things in relation to the above-mentioned assets, properties and rights which Purchaser, its successors or assigns may deem desirable, Seller hereby declaring that the foregoing powers are coupled with an interest and are not revocable and shall not be revoked by Seller for any reason whatsoever.

Section 2. Seller authorizes Purchaser, its successors and assigns to receive and open all mail, telegrams and other communications, and all express or other packages, addressed to Seller at its address set forth above and to retain the same insofar as they relate to the Assets, but any such mail, telegrams, communications or express or other packages (or copies thereof) not relating primarily to the Assets shall be forwarded forthwith to Seller at the address from time to time specified in writing by Seller for such purposes. The foregoing shall constitute full authorization to the postal authorities, all telegraph and express companies, and all other persons to make delivery of such items to Purchaser.

Section 3. Seller for itself, its successors and assigns hereby covenant and agree that, any time and from time to time forthwith upon the written request of Purchaser, Seller will, at Purchaser's expense, do, execute, acknowledge and deliver or cause to be done, executed, acknowledged or delivered, all and every such further acts, deeds, assignments and transfers reasonably required or requested by Purchaser in order to assign, transfer, set over, convey, release, assure and confirm unto, and vest in, Purchaser, its successors and assigns, or to aid and assist Purchaser in collecting or reducing to possession any or all of the Assets assigned or to be assigned to Purchaser.



Section 5. This Bill of Sale and Assignment is an instrument of transfer contemplated by, and is executed pursuant to, and shall be construed in accordance with the Asset Purchase Agreement and the right and obligations of the parties hereunder are subject to all the terms and conditions of the Asset Purchase Agreement.
