## TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment") dated as of October 2, 2007 (the "Assignment Effective Date"), by and between EMD Chemicals Inc., a New York corporation ("Assignor"), and Mylan Laboratories Inc., a Pennsylvania corporation ("Assignee"), (together with Assignor, the "Parties," and each individually a "Party").

### WITNESSETH:

WHEREAS, Merck KGaA, certain Affiliates of Merck KGaA (the "Sellers") and Assignee are parties to a Share Purchase Agreement dated 12 May 2007 (the "Purchase Agreement"), pursuant to which the Sellers agreed to cause Assignor to transfer to Assignee and Assignee agreed to acquire from Assignor, the trademarks listed on Attachment 1 hereto (the "Trademarks"), and all goodwill associated therewith and symbolized thereby; and

WHEREAS, Assignee desires to acquire from Assignor, and Assignor desires to transfer to Assignee all Assignor's right, title and interest in and to the Trademarks, and all goodwill associated therewith and symbolized thereby;

NOW, THEREFORE, in consideration of the premises and of the mutual covenants, agreements, representations and warranties contained herein and in the Purchase Agreement, intending to be legally bound hereby, the Parties do hereby agree as follows:

### ARTICLE I

#### DEFINITIONS

1.1 Capitalized terms used in this Assignment but not otherwise defined herein shall have the meanings ascribed thereto in the Purchase Agreement.

### ARTICLE II

#### ASSIGNMENT OF TRADEMARKS

2.1 Assignor does hereby irrevocably assign, transfer, convey, and deliver to Assignee and its successors and assigns, and Assignee hereby accepts, all of Assignor's rights, title, and interests in and to the Trademarks, and all goodwill associated therewith and symbolized thereby, and any registrations thereof and applications therefore.

2.2 Assignor shall, without further consideration, cause to be performed such lawful acts, and to execute such further assignments and other lawful documents, as Assignee may reasonably request to perfect or record Assignee's right, title and interest in and to any of the Trademarks and to carry out and fulfill the purposes and intent of this Assignment, including, but not limited to, executing all documents necessary to record in the name of Assignee the assignment of any of the Trademarks with the Commissioner of Patents and Trademarks and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar).

2.3 With respect to any Trademarks consisting of Internet domain names, Assignor shall cooperate with Assignee to transfer (or cause to be transferred) such Internet domain names electronically from Assignor's (or the applicable record owners' and/or administrative contacts') account to Assignee's account as quickly as reasonably practicable (such that Assignee will be listed as the registrant of such domain names in the WHOIS database). Assignor further shall (and shall cause the applicable record owners and/or administrative contacts to): (i) complete, execute, notarize (as necessary), and deliver at any future date any additional documents that are reasonably necessary to perfect Assignee's ownership of such Internet domain names including, but not limited to, any transfer documents required by a domain name registrar; and (ii) generally provide all further cooperation, including taking such further action and executing such additional documents, which Assignee or its successors and assigns reasonably request to secure, obtain or enforce proper protection for such domain names and all associated rights in this or any foreign country.

2.4 Assignee shall prepare any such assignments and any other documents described in Sections 2.2 and 2.3 at its sole expense, shall pay any applicable transfer, filing or recording fees and shall reimburse Assignor for any costs and expenses incurred by Assignor in connection with the activities described herein.

2.5 The Parties hereby authorize and request the Commissioner of Patents and Trademarks, the applicable Internet domain name registration authorities, and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar), to record Assignee as the owner of the Trademarks and to issue any and all Trademarks to Assignee as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee and each of its successors, assigns or other legal representatives. Assignee shall have the right to record this Assignment with all applicable government authorities and registrars so as to perfect its ownership of the Trademarks.

**ARTICLE III**

**PURCHASE PRICE**

3.1 The aggregate purchase price to be paid hereunder shall be Euro Twenty-Two Million (EUR 22,000,000) (the "Purchase Price").

**ARTICLE IV**

**MISCELLANEOUS**

4.1 This Assignment, including all matters of construction, validity and performance, shall be governed by and construed in accordance with the laws of the State of New York without regard to the principles of conflicts or choice of laws or any other law that would make the laws of any other jurisdiction other than the State of New York applicable hereto.

IN WITNESS WHEREOF, the Parties hereto have caused this Assignment to be duly executed and delivered by the duly authorized officer of each of Assignor and Assignee as of the Assignment Effective Date.
