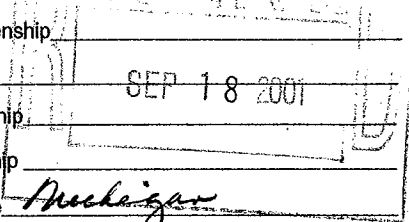

required to apply for, obtain, maintain, issue, and enforce said applications, and said trademarks which may be necessary or desirable to carry out the purposes hereof.

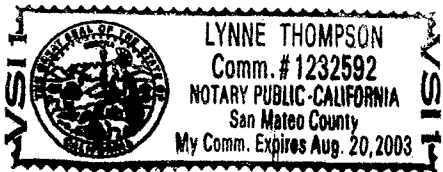
