SECURITY AGREEMENT (TRADEMARKS)

This SECURITY AGREEMENT (TRADEMARKS) (this "**Agreement**") is made as of January 31, 2008, by and between STRIDE & ASSOCIATES, INC., a Delaware corporation (the "**Borrower**") and RBS CITIZENS, NATIONAL ASSOCIATION, a national banking association (as successor by merger to Citizens Bank of Massachusetts)(the "**Lender**").

All capitalized terms not defined herein but defined in the Second Amended and Restated Security Agreement-All Assets, dated of even date herewith (as the same may be amended, modified, supplemented, extended or restated, from time to time, the "**Security Agreement-All Assets**") by and between the Borrower and the Lender, shall have the meanings given to such terms in the Security Agreement-All Assets.

Preliminary Statements:

WHEREAS, the Borrower has requested that the Existing Credit Agreement be amended, restated and replaced in its entirety as provided for in the Credit Agreement in order for the Lender to grant certain financial accommodations to and for the benefit of the Borrower, all as more particularly described therein; and

WHEREAS, the Borrower owns, has adopted, used and is using the trademarks and service marks (and has filed the trademark applications and service mark applications) set forth in **Schedule 1** attached hereto and made a part hereof (collectively, the "**Trademarks**"); and

WHEREAS, in order to induce the Lender to enter into the Credit Agreement and to grant such financial accommodations to and for the benefit of the Borrower, all as more particularly described therein, and as a supplement to the Security Agreement-All Assets, the Lender has requested, and the Borrower has agreed to enter into this Agreement;

NOW, THEREFORE, in order to induce the Lender to enter into the Credit Agreement and to grant such financial accommodations to and for the benefit of the Borrower, all as more particularly described therein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Borrower hereby agrees with the Lender as follows:

1. To secure the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations, the Borrower does hereby grant to the Lender a continuing security interest in and to the Trademarks and all General Intangibles connected with the use of or related to any and all Trademarks (including without limitation, all goodwill of the Borrower and its business, products and services appurtenant to, associated with or symbolized by any and all Trademarks and the use thereof), together with all registrations of the Trademarks and the applications therefor, all in accordance with the terms and provisions of the Security Agreement-All Assets.

2. The Borrower and the Lender hereby expressly acknowledge and agree that all of the rights and remedies of the Lender with respect to the security interest granted hereby are more fully set forth in the Security Agreement-All Assets.
