


**TRADEMARK ASSIGNMENT**



Assignor also hereby assigns its foreign rights to the Trademark in all trademark granting countries of the world, including the right to file applications or obtain trademark registrations in its own name in the countries under the terms of the Paris Convention for the Protection of Intellectual Property, together with all of Assignor's rights of priority and all other rights under any and all international agreements to which the United States adheres. Assignor hereby authorizes and requests any official, whose duty it is to issue in any country trademark registration, to issue trademark registrations to Assignee or its nominees, successors or assigns, as Assignee may from time-to-time request.

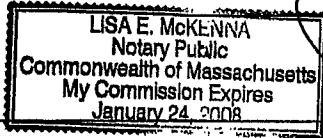
