TRADEMARK ASSIGNMENT

WHEREAS, Klinger Advanced Aesthetics, LLC, *et al.*¹, (collectively, the “Debtors”) and specifically **GK ACQUISITION, LLC (one of the Debtors)** a Delaware Limited Liability Company with offices formerly located at The Mall at Short Hills, Suite A-139, 1200 Morris Turnpike, Short Hills, NJ 07078, United States of America is the owner of and has adopted, used and is using the trademarks set forth on the attached Schedule “A,” registered in the United States Patent and Trademark Office or for which application(s) for registration have been filed in the United States Patent and Trademark Office (the “Trademarks”);

WHEREAS, on or about July 25, 2007, the Debtors filed a petition for relief under Chapter 11 of title 11 of the United States Bankruptcy Code in the United States Bankruptcy Court for the District of New Jersey (the “Bankruptcy Court”);

WHEREAS, on or about January 3, 2008, an order was entered by the Bankruptcy Court converting the Debtors’ cases to Chapter 7;

WHEREAS, on or about January 4, 2008, Joseph J. Newman was appointed as Chapter 7 Trustee for the Debtors (hereinafter the “ASSIGNOR”);

WHEREAS, **KAMAS HOLDINGS, LLC** a limited liability company organized and existing under the laws of the State of Delaware, with an office at c/o Kane Kessler, P.C., 1350 Avenue of the Americas, New York, NY 10019, United States of America (hereinafter called the “ASSIGNEE”) is desirous of acquiring all right, title and interest owned by ASSIGNOR in and to the Trademarks and the registrations thereof;

¹ In addition to Klinger Advanced Aesthetics, LLC, the following entities, all of which are wholly owned subsidiaries of Klinger Advanced Aesthetics, LLC, also filed Chapter 11 Petitions on or after the Petition Date: (a) Anushka PBG Acquisition Sub, LLC; (b) Anushka Boca Acquisition Sub, LLC, (c) Wild Hare Acquisition Sub, LLC, (d) Dischino Corporation, (e) GK Acquisition, LLC; and (f) Georgette Klinger LLC (“GK Parent”), which were administratively consolidated by Order entered July 30, 2007.

WHEREAS, on March 25, 2008, the Bankruptcy Court entered an order approving the sale of the Trademarks to ASSIGNEE.


