TRADEMARK ASSIGNMENT AGREEMENT - #16

THIS TRADEMARK ASSIGNMENT AGREEMENT, dated as of the 14th day of December, 2007 by and between **Tyco Healthcare Retail Services AG**, a corporation organized under the laws of Switzerland ("THRSAG") and **Tyco Healthcare Retail Group, Inc.**, a corporation organized under the laws of the State of Delaware ("RGI"). THRSAG and RGI are herein referred to collectively as the "Parties".

WITNESSETH:

WHEREAS, THRSAG is the record holder of all right, title and interest in the trademarks, service marks and related trademark and service mark Registrations and Applications listed in Exhibit A (collectively, the "Marks");

WHEREAS, THRSAG and RGI have been related companies under common ownership, such that THRSAG has been record title holder to the Marks; and whereas for U.S. income tax purposes RGI is the beneficial owner of the Marks;

WHEREAS, it is now contemplated that THRSAG and RGI will become members of different business entities, and it therefore will become necessary to assign the Marks to RGI;

NOW, THEREFORE, in consideration of the foregoing, and for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, THRSAG hereby assigns unto RGI, its successors and assigns, the entire right, title and interest in and to the Marks (including, without limitation, the Registrations and Applications listed in Exhibit A), together with the goodwill of the business connected with and symbolized by the Marks, and all income, royalties, damages and payments now or hereafter due or payable in respect to the Marks and all causes of action (either in law or in equity) and the right to sue, counterclaim and recover for past, present and future infringement and/or dilution of the same.

THRSAG agrees to provide any additional documents reasonably requested by RGI in connection with the assignment of the Marks.


