## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment") is made effective as of March 31, 2008, by and between Tradewinds Trading Company, Inc. d/b/a TW Medical Veterinary Supply ("Assignor"), and The Pet Blood Bank, Inc. ("Assignee"):

WHEREAS, Assignee is the owner of all assets used in conducting the business known as "The Pet Blood Bank" (the "Business"), including without limitation that certain trademark registered with the United States Patent and Trademark Office (the "USPTO") as Reg. No. 3,003,766, consisting of a black paw print with the adjoined far left imprint of the paw being a red drop of blood, and including the phrases "The Pet Blood Bank" and "Pets Helping Pets", all as depicted on Exhibit A attached hereto (the "Mark"), together with the goodwill of the business symbolized thereby in connection with the goods on which the Mark is used (the "Products");

WHEREAS, the Mark was inadvertently and mistakenly registered with the USPTO in the name of Assignor as the owner, rather than Assignee, who is the true owner of the Mark; and

WHEREAS, Assignor desires to assign, convey, transfer, deliver, contribute and release to Assignee all of its right, title and interest, if any, in and to the Mark, the Products and the Business.

NOW, THEREFORE, in consideration of the payment of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby conveys, transfers, assigns, delivers, and contributes to Assignee all of Assignor's right, title, and interest of whatever kind in and to the Mark, the Products and the Business, together with (1) the goodwill of the Business relating to the Products in respect upon which the Mark is used and for which it is registered; (2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Mark, including without limitation, damages, and payments for past or future infringements and misappropriations of the Mark; and (3) all rights to sue for past, present and future infringements or misappropriations of the Mark.

Assignor further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing , completing, or vesting in Assignee full right, title, and interest in the Mark, the Products or the Business.

Assignee hereby covenants and agrees that it shall indemnify, defend and hold harmless Assignor and its officers, directors, shareholders, employees, agents, successors and assigns, from and against any claim, liability, obligation, loss, damage, assessment, judgment, cost, expense, action, suit, proceeding or demand of any kind or character

(including without limitation reasonable attorney's fees and expenses and costs reasonably incurred in investigating, preparing or defending any litigation or claim) resulting from or attributable to this Assignment or the registration or use of the Mark by Assignee, including without limitation infringement claims brought by third persons.
