**ASSIGNMENT OF TRADEMARK RIGHTS AND  
ASSUMPTION OF CERTAIN OBLIGATIONS - #5**

**THIS ASSIGNMENT AND ASSUMPTION AGREEMENT**, dated as of the 13<sup>th</sup> day of December, 2007 by and between **United States Surgical Corporation**, a corporation organized under the laws of the State of Delaware ("USSC") and **Tyco Healthcare Retail Group, Inc.**, a corporation organized under the laws of the State of Delaware and a direct, wholly-owned subsidiary of USSC ("RGI").

**WITNESSETH:**

**WHEREAS**, USSC is a party to a trademark assignment agreement dated December 13, 2007 with **Tyco Healthcare Group LP**, a partnership organized under the laws of the State of Delaware ("THGLP") relating to the trademark FLEXI-WINGS associated with feminine hygiene products (hereinafter referred to as the "Trademark Assignment Agreement");


**WHEREAS**, RGI is a wholly owned subsidiary of USSC;

**WHEREAS**, RGI desires to assume the rights and obligations of USSC under said Trademark Assignment Agreement;


**NOW, THEREFORE**, in consideration of the foregoing and other consideration, the receipt of which is hereby acknowledged, USSC, intending to be legally bound, hereby assigns its rights and obligations under said Trademark Assignment Agreement to RGI and RGI hereby accepts said rights and obligations. USSC and RGI further agree that this agreement is intended to qualify as, and will be treated by both parties as, a tax-free contribution of property by USSC to RGI under Section 351 of the Internal Revenue Code of 1986, as amended (the "Code").
