**ASSIGNMENT OF UNITED STATES  
TRADEMARK RIGHTS**

This ASSIGNMENT OF UNITED STATES TRADEMARK RIGHTS (this "Assignment") is made and executed as of June 30, 2002, by and between Friede Goldman United, Ltd., a Cayman Islands company (hereinafter referred to as the "Assignee") and United Heavy B.V., a Netherlands company (hereinafter referred to as the "UH").

**Recitals**

WHEREAS, UH having a correspondence address of Jan Luijkenstraat 92-N, 1071 CT, Amsterdam, Netherlands, has acquired the Registered Trademarks and Service Marks listed on Appendix "A", as well as unregistered or "common law" trademarks, service marks or trade names listed on Appendix "A" (collectively, the "Trademark Rights") pursuant to that certain Assignment of United States Trademark Rights between UH and Friede & Goldman, Ltd., a Mississippi corporation, dated June 25, 2002 (the "FGL Assignment") and the goodwill associated therewith in the business of offshore structures; and

WHEREAS, Assignee having a correspondence address of 10375 Richmond Avenue, Suite 1200, Houston, Texas 77042 ATTN: Paul Geiger, Jr., desires to acquire all of UH's right, title and interest in, to and under said Trademark Rights, together with the goodwill of the business of UH in connection with which the Trademark Rights are used and which is symbolized by the Trademark Rights, along with the right to recover for damages and profits for past infringements thereof;

**Agreement**

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignment. UH has agreed to and does hereby irrevocably sell, assign, and transfer to Assignee all of UH's right, title and interest in and to said Trademark Rights together with the goodwill of the business of UH in connection with which the Trademark Rights are used and which is symbolized by the Trademark Rights, along with the right to recover for damages and profits for past infringements thereof, and the registration thereof, to have and to hold the Trademark Rights together with all rights and appurtenances of UH thereto, including such goodwill, to the end of the term or terms for which the Trademark Rights may be granted. UH represents and warrants that it has made no conveyance, assignment, grant, mortgage, license or other agreement affecting the rights and property herein assigned to any other person.

2. Authorization. UH hereby authorizes the Commissioner of Patents and Trademarks of the United States to issue the Trademark Rights to Assignee in accordance with the terms of this instrument.

3. Further Assurances. UH covenants and agrees that it will, at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title to the Trademark Rights of the Assignee, its successors, assigns, or other legal representatives, and it will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite, without further compensation but at the expense of said Assignee, its successors, or other legal representatives.

4. Further Information. UH covenants and agrees that it will, at any time upon request, communicate to the Assignee, its successors, assigns or other legal representatives, such facts relating to the Trademark Rights, and any other worldly rights not expressly referenced herein or the file history thereof as may be known to UH or its agents or legal representatives, and testify as to the same in any interference or other litigation when requested so to do, without further compensation but at the expense of said Assignee, its successors, or other legal representatives.

IN WITNESS WHEREOF, the parties hereto have caused this Assignment to be executed as of the day and year first above written.
