NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby transfers, sells, assigns and sets over unto Assignee, its successors and assigns, Assignor's entire right, title and interest in and to the Trademark, together with the business of Assignor that is associated with the intended use of the Trademark, and, to the extent Assignor has begun using the Trademark, together with the goodwill of the business in connection with which the Trademark are used, along with all rights to income, royalties, damages and payments now or hereafter due or payable with respect thereto, and to all causes of action (either in law or in equity) together with the right to sue and recover damages, and profits and any other available remedies for any past, present or future infringement thereof, as fully and entirely as the same would have been held and enjoyed by Assignor had this transfer and assignment not been made.

Assignor covenants and agrees that it will, without charge to Assignee, whenever so required by Assignee, execute and deliver such further instruments and perform any other reasonable acts that Assignee may require as may be necessary or convenient for vesting in Assignee the full benefit of all of the rights and premises hereby assigned and/or provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee, to the extent such evidence is in possession or control of Assignor.
