DEED OF ASSIGNMENT

THIS DEED OF ASSIGNMENT is made on 15 May 2007

BETWEEN:

- (1) **CLIFFORD CHANCE LIMITED LIABILITY PARTNERSHIP**, a limited liability partnership organised and registered under the laws of the State of New York (until its registration as a limited liability partnership in the State of New York which took effect on 1 January 2000 known as **CLIFFORD CHANCE**), whose place of business is at 10 Upper Bank Street, London E14 5JJ, United Kingdom (until (the "Assignor"); and
- (2) **CLIFFORD CHANCE LLP**, a limited liability partnership, incorporated in England and Wales (registered no. OC323571), whose registered office is at 10 Upper Bank Street, London E14 5JJ, United Kingdom (the "Assignee").

THE PARTIES AGREE as follows:

1. **DEFINITIONS**

1.1. In this Deed of Assignment:

"Conversion Agreement" means the conversion agreement between the Assignor and the Assignee dated 2 December 2006 in which the Assignor agreed to assign its assets to the Assignee; and

"Trade Marks" means the trade marks listed in the schedule to this Assignment.

2. **ASSIGNMENT**

Pursuant and subject to the Conversion Agreement, the Assignor hereby assigns and transfers to the Assignee absolutely with full title guarantee

- (a) all of its right, title and interest in the Trade Marks and all legal rights and immunities (howsoever derived) attaching thereto, free from all liens, charges or encumbrances; and
- (b) the right to sue for and to recover damages and other remedies in respect of any infringement of the Trade Marks which may have occurred before the date of this Deed of Assignment.

3. **FURTHER ASSURANCE**

The Assignor shall on request by the Assignee and at the Assignee's expense do and execute or arrange for the doing and executing of, each necessary act, document and thing to implement this Deed of Assignment.

4. **ASSISTANCE WITH PROCEEDINGS**

If in any proceedings a claim is made, at any time impugning the validity of a Trade Mark or challenging the entitlement of the Assignee to be the holder of a Trade Mark,
