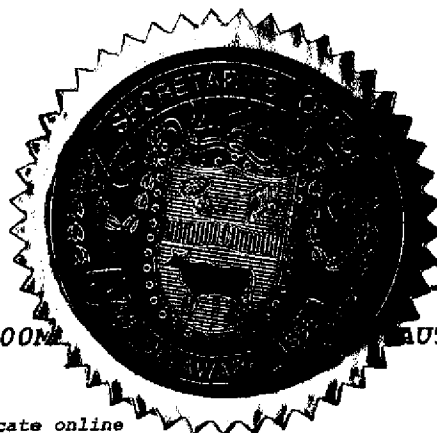

FIRST: BSG ALLIANCE CORP. (the "Corporation") is a business corporation of the state of Delaware.

SECOND: The Corporation is the owner of all of the outstanding shares of the stock of The Concours Group, Inc., which is also a business corporation of the State of Delaware.

RESOLVED FURTHER, that the Corporation shall cause to be executed, filed and recorded, as appropriate, the documents prescribed by the laws of the State of Delaware and by the laws of any other appropriate jurisdiction and will cause to be performed all necessary acts within the State of Delaware and within any other appropriate jurisdiction to effect the purposes of these resolutions.

RESOLVED FURTHER, that merger shall be effective as of December 31, 2007, and the effective time of the Certificate of Ownership and Merger to be filed with the Delaware Secretary of state shall also be effective as of said date.
