SUPPLEMENT NO. 1 TO THE TRADEMARK SECURITY AGREEMENT DATED AS OF NOVEMBER 9, 2007

WHREAS, pursuant to the terms of that certain Credit, Security, Pledge and Guaranty Agreement, dated as of November 9, 2007, as amended and restated as of April 30, 2008 (as the same may be further amended, supplemented or otherwise modified, renewed or replaced from time to time, the "Credit Agreement") among Echo Bridge Entertainment, LLC and Platinum Disc, LLC (together, the "Borrowers"), the Guarantors referred to therein (the Borrowers and the Guarantors being collectively referred to as the "Pledgors", and each individually as "Pledgor"), the Lenders referred to therein (the "Lenders") and JPMorgan Chase Bank, National Association, as Administrative Agent (in its capacity as such, the "Administrative Agent") and as issuing bank (in such capacity, the "Issuing Bank"), the Lenders have agreed to make loans to the Borrowers and the Issuing Bank has agreed to issue and the Lenders have agreed to participate in letters of credit for the account of the Borrowers;

WHEREAS, pursuant to an Amended and Restated Credit, Security, Pledge and Guaranty Agreement (the "Amended Credit Agreement"), dated as of April 30, 2008, Alliance Atlantis International Distribution, LLC, a Delaware limited liability company (the "New Pledgor"), has, among other things, become a Guarantor (as defined in the Credit Agreement) under the Credit Agreement and a Pledgor (as defined in the Trademark Security Agreement referred to below) under such Trademark Security Agreement;

WHEREAS, pursuant to the terms of the Credit Agreement and the Amended Credit Agreement among the Pledgors, the Lenders and the Administrative Agent, each of the Borrowers and Guarantors (the "Existing Pledgors", and together with the New Pledgor, the "Pledgors", and each individually "Pledgor") have granted to the Administrative Agent (for the benefit of itself and the Lenders) a security interest in all personal property of the Pledgors whether now owned, presently existing or hereafter acquired or created, including, without limitation, all right, title and interest of the Pledgors in, to and under any Trademarks and Trademark licenses, whether now existing or hereafter arising, acquired or created, and all proceeds thereof or income therefrom, to secure the payment and performance of the Obligations (as such term is defined in the Credit Agreement);

WHEREAS, each of the Pledgors is a party to a Trademark Security Agreement dated as of November 9, 2007 (as the same has been, or may hereafter be, amended or supplemented from time to time, the "Trademark Security Agreement"), pursuant to which each of the Pledgors has granted to the Administrative Agent (for the benefit of itself and the Lenders), as security for the Obligations, a continuing security interest in and to all personal property of the Pledgors including, without limitation, all right, title and interest of the Pledgors in, to and under all of the Pledgors' Trademarks and Trademark licenses, whether now owned, presently existing or hereafter arising, adopted or acquired and whether or not in possession of the Pledgors, together with the goodwill of the business connected with, and symbolized by, the Trademarks and all products and proceeds thereof and all income therefrom, including, without

limitation, any and all causes of action which exist now or may exist in the future by reason of infringement or dilution thereof or injury to the associated goodwill, to secure the payment and performance of the Obligations;

WHEREAS, the Pledgors have acquired or created additional Trademarks since the date of execution of the Trademark Security Agreement;

WHEREAS, Schedule A to the Trademark Security Agreement does not reflect all Trademarks acquired or created by the Pledgors since the date of execution of the Trademark Security Agreement;

THEREFORE,

- A. Each of the Pledgors does hereby grant to the Administrative Agent (for the benefit of itself and the Lenders), as security for the Obligations, a continuing security interest in and to all of such Pledgor's right, title and interest in and to each and every Trademark added to Schedule A to the Trademark Security Agreement, pursuant to paragraph B below, together with the goodwill of the business connected with, and symbolized by, the Trademarks and all products and proceeds thereof and all income therefrom, including, without limitation, any and all causes of action which exist now or may exist in the future by reason of infringement or dilution thereof or injury to the associated goodwill, to secure the payment and performance of the Obligations, all as contemplated by, and as more fully set forth in, the Trademark Security Agreement.
- B. The Trademark Security Agreement is hereby supplemented, effective as of the date hereof, by amending Schedule A thereof so as to reflect all of the Trademarks in and to which any Pledgor has granted a continuing security interest to the Administrative Agent (for the benefit of itself and the Lenders) pursuant to the terms of the Trademark Security Agreement and the Credit Agreement.

The Trademarks listed on the schedule 1 hereto are hereby added to Schedule A to the Trademark Security Agreement:

Except as expressly supplemented hereby, the Trademark Security Agreement shall continue in full force and effect in accordance with the provisions thereof on the date hereof. As used in the Trademark Security Agreement, the terms "Agreement," "this Agreement," "this Trademark Security Agreement," "herein," "hereafter," "hereto," "hereof" and words of similar import, shall, unless the context otherwise requires, mean the Trademark Security Agreement as supplemented by this Supplement.

Except as expressly supplemented hereby, the Trademark Security Agreement, all documents contemplated thereby and any previously executed Supplements thereto, are each hereby confirmed and ratified by each of the Pledgors.

The execution and filing of this Supplement, and the addition of the Trademarks and Trademark licenses set forth herein are not intended by the parties to derogate from, or extinguish, any of the Administrative Agent's rights or remedies under (i) the Trademark Security Agreement and/or any agreement, amendment or supplement thereto or any other

instrument executed by the Pledgor and heretofore recorded or submitted for recording in the U.S. Patent and Trademark Office or (ii) any financing statement, continuation statement, deed or charge or other instrument executed by the Pledgor and heretofore filed in any state or county in the United States of America or elsewhere.




