**TERMINATION AND RELEASE OF SECURITY INTEREST IN  
TRADEMARK RIGHTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS** ("Termination and Release"), dated as of May 14, 2008 ("Effective Date") is given by Comerica Bank, a Michigan banking corporation, located at One Detroit Center, 9<sup>th</sup> Floor, 500 Woodward Avenue, Detroit, Michigan 48226 ("Bank").

**WHEREAS**, pursuant to that certain Credit Agreement dated as of September 16, 2002, and subsequent amendments entered thereafter, KBF Acquisition Corp., a Delaware corporation t/b/k/a Kathryn Beich, Inc., a Delaware corporation (the "Borrower") granted a security interest (the "Security Interest") to Bank in certain trademark rights, including the trademark registrations set forth on Exhibit A attached hereto (the "Trademark Collateral"), and executed a Security Agreement securing the Bank's interest in such Trademark Collateral (the "Security Agreement"); and


**WHEREAS**, an executed copy of the Security Agreement was recorded at the U.S. Patent and Trademark Office on September 23, 2002 at Reel 002592, Frame 0151; and

**WHEREAS**, the Bank now desires to terminate and release the entirety of its Security Interest in and to the Trademark Collateral.

**NOW THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, Bank hereby terminates and releases the Security Interest in the Trademark Collateral.
