This INTELLECTUAL PROPERTY COLLATERAL AGREEMENT (SECOND LIEN) dated as January 11, 2008, is among NEW ENTERPRISE STONE & LIME CO., INC., a Delaware corporation (together with its successors and permitted assigns, the “**Borrower**”), and MARTIN LIMESTONE, INC., a Pennsylvania corporation and a wholly-owned subsidiary of the Borrower (“**Martin**”), VALLEY QUARRIES, INC., a Pennsylvania corporation and a wholly-owned subsidiary of the Borrower (“**Valley**”), NEW ENTERPRISE TRANSPORTATION, INC., a Pennsylvania corporation and a wholly-owned subsidiary of the Borrower (“**NETI**”), STAR CARRIERS, INC., a Pennsylvania corporation and a wholly-owned subsidiary of the Borrower (“**Star Carriers**”), BLAIR-BEDFORD PAVING COMPANY, INC., a Pennsylvania corporation and a wholly-owned subsidiary of the Borrower (“**Blair Bedford**”), NESL BUFFALO HOLDINGS, INC., a Delaware corporation and a wholly-owned subsidiary of the Borrower (“**Buffalo**”), ABC PAVING CO., INC., a New York corporation and a wholly-owned subsidiary of Buffalo (“**ABC Paving**”), 2544 CLINTON, INC., a New York corporation and a wholly-owned subsidiary of Buffalo (“**2544 Clinton**”), E.R.S.C., INC., a New York corporation and a wholly-owned subsidiary of ABC Paving (“**ERSC**”), GATEWAY TRADE CENTER INC., a New York corporation and a wholly-owned subsidiary of 2544 Clinton (“**Gateway**”), BUFFALO CRUSHED STONE INC., a New York corporation and a wholly-owned subsidiary of 2544 Clinton (“**BCS**”), STABLER COMPANIES INC., a Pennsylvania corporation and a wholly-owned subsidiary of the Borrower (“**SCI**”), PROTECTION SERVICES INC., a Pennsylvania corporation and a wholly-owned subsidiary of SCI (“**PSI**”),

SCI PRODUCTS INC., a Pennsylvania corporation and a wholly-owned subsidiary of SCI (“**Products**”), WORK AREA PROTECTION CORP., an Illinois corporation and a wholly-owned subsidiary of SCI (“**Work Area**”), EASTERN INDUSTRIES, INC., a Pennsylvania corporation and a wholly-owned subsidiary of SCI (“**Eastern**”), STABLER DEVELOPMENT COMPANY, a Pennsylvania corporation and a wholly-owned subsidiary of SCI (“**Development**”), ELCO-HAUSMAN CONSTRUCTION CORPORATION, a Pennsylvania corporation and a wholly-owned subsidiary of together of Eastern (“**Elco-Hausman**”), EII TRANSPORT INC., a Pennsylvania corporation and a wholly-owned subsidiary of Eastern (“**EII**”), PRECISION SOLAR CONTROLS INC., a Texas corporation and a wholly-owned subsidiary of SCI (“**Precision**”) and ASTI TRANSPORTATION SYSTEMS, INC., a Delaware corporation and a wholly-owned subsidiary of SCI (“**ASTI**” with Borrower, Martin, Valley, NETI, Star Carriers, Blair Bedford, Buffalo, ABC Paving, 2544 Clinton, ERSC, Gateway, BCS, SCI, PSI, Products, Work Area, Eastern, Development, Elco-Hausman, EII, Precision, and any other Person that becomes a party to the Security Agreement (as referenced and defined below), together with their successors and permitted assigns, collectively, “**Assignors**”) and MANUFACTURERS AND TRADERS TRUST COMPANY, with an office at 301 W. Plank Road, Altoona, Pennsylvania 16602, as agent for itself and the other Secured Parties (as that term is defined in the Credit Agreement referenced below) (together with its successors and assigns in such capacity, “**Assignee**”) and is made pursuant to the Second Lien Security Agreement dated as of the date hereof, by and among Assignors and Assignee (the “**Security Agreement**”).

WHEREAS, Assignors are the owners of certain United States and international patents and/or patent applications, including those listed on Exhibit 1 hereto (the “**Patents**”); and

WHEREAS, Assignors are the owners of certain trademarks, including pending applications and/or registrations therefor, together with the goodwill of the business connected with the use of and symbolized thereby, including those listed on Exhibit 1 hereto (the “**Marks**,” which, together with the Patents and the other items defined as “Intellectual Property” in the Credit Agreement shall be collectively referred to hereinafter as the “**Intellectual Property**”); and

WHEREAS, Assignors, Assignee and certain Lenders (as defined in the Credit Agreement) entered into that certain Second Lien Credit Agreement dated as of the date hereof (as the same may be amended, restated, modified, supplemented and/or replaced from time to time, the “**Credit Agreement**”), pursuant to which such Lenders and the other Secured Parties agreed to extend credit to the Assignors on the terms and conditions described therein; and

WHEREAS, one of the conditions to the extension of credit under the Credit Agreement is that payment of the Secured Obligations (as defined in the Credit Agreement) shall be secured by, among other things, a security interest in favor of the Assignee, for the benefit of the Lenders and the other Secured Parties, in the Intellectual Property and all Proceeds (as defined in the Security Agreement) thereof subordinate only to the First Lien Obligations (as defined in the Intercreditor Agreement (as defined below)) and Assignors are willing to grant to the Assignee, for the benefit of the Secured Parties, a security interest in the Intellectual Property and all Proceeds thereof subordinate only to the First Lien Obligations (as defined in the Intercreditor Agreement (as defined below)) and all other related claims and rights as more fully described in the Security Agreement.

WHEREAS, the Assignee is party to a certain Intercreditor Agreement, dated on or about the date hereof, among Borrower and the agent for certain first lien obligations (as the same may

be amended, restated, modified, supplemented, from time to time, the “**Intercreditor Agreement**”).

NOW, THEREFORE, for good and valuable consideration, as security for the due and timely payment and performance of the Secured Obligations, Assignors hereby pledge and grant to Assignee a security interest and lien in and to the Intellectual Property and all Proceeds thereof subordinate only to the First Lien Obligations (as defined in the Intercreditor Agreement) and give notice of such security interest and the existence of the Security Agreement providing therefor.

Notwithstanding anything herein to the contrary, the lien and security interest granted to the Assignee pursuant to this Agreement and the exercise of any right or remedy by the Assignee hereunder are subject to the provisions of the Intercreditor Agreement. In the event of any conflict between the terms of the Intercreditor Agreement and this Agreement, the terms of the Intercreditor Agreement shall govern and control.


