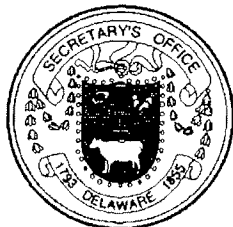

SECOND: The date of filing of the LLC's original Certificate of Formation with the Secretary of State of Delaware was July 13, 1999.


