## RELEASE OF SECURITY INTEREST

**THIS RELEASE OF SECURITY INTEREST** (this "Release") is made as of May 1, 2008 ("Effective Date") by and between JP Morgan Chase & Co., f/k/a American National Bank & Trust Company of Chicago, a Delaware corporation, with its principal office at 10 South Dearborn Street, Chicago, Illinois 60603 ("Grantee"), and Duramax, Inc., an Ohio corporation, with its principal office at 16025 Johnson Street, Middlefield, Ohio 44062 ("Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain Additional Patent, Trademark and License Mortgage by and between Grantor and Grantee, dated July 15, 1992 (the "Security Agreement"), Grantor granted to Grantee a security interest in all of Grantor's right, title and interest in and to all of Grantor's Patents, Trademarks and Licenses (as each term is defined in the Security Agreement), including, without limitation, the Patents set forth on Schedule A, the Trademarks set forth on Schedule B, and the Licenses set forth on Schedule C;

**WHEREAS**, the Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on July 31, 1992, at Reel 0905, Frame 0241; and

**WHEREAS**, Grantor has satisfied all of its outstanding obligations owed to Grantee.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor and Grantee hereby agree as follows:

Grantee hereby terminates the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Patents, Trademarks and Licenses.

Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any right, title or interest in or to the Patents, Trademarks or Licenses; and (iii) it has not recorded or otherwise evidenced its security interest with respect to any Patents, Trademarks or Licenses, other than those set forth on Schedules A, B or C, in any jurisdiction throughout the world;

Grantee shall, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.



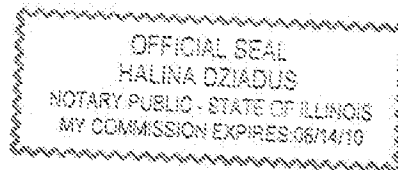
