

ATTACHMENT TO THE AMENDMENT OF ARTICLES OF INCORPORATION OF BILLIARDS ACQUISITION, INC.

The following Article shall be added to the Articles of Incorporation:

Article Eight

RECORDED: 05/15/2008

The directors of the corporation shall not be personally liable to the corporation or its shareholders for monetary damages for breach of fiduciary duty as a director, provided that such provision shall not eliminate or limit the liability of a director (a) for any breach of the director's duty of loyalty to the corporation or its shareholders, (b) for acts or omissions not in subjective good faith or which involve intentional misconduct or a knowing violation of law, (c) pursuant to section 345 of the General and Business Corporation Law of Missouri or (d) for any transaction from which the director derived an improper personal benefit. This Article shall not eliminate the liability of a director for any act or omission occurring prior to the date when this Article becomes effective.
