TRADEMARK RELEASE AND REASSIGNMENT

This TRADEMARK RELEASE AND REASSIGNMENT is made as of February 28, 2008, by Coöperatieve Centrale Raiffeisen-Boerenleenbank B.A., "Rabobank International", New York Branch, as Administrative Agent for the Lenders under that certain Amended and Restated Term Loan Credit Agreement dated as of December 11, 2006 by and among the Grantors (as defined below), the Lenders and Administrative Agent ("Administrative Agent").

WITNESSETH:

WHEREAS, Administrative Agent, Consolidated Coffee, Inc., a Delaware corporation ("Parent"), Eight O'Clock Coffee Company, a Delaware corporation ("EOC"), and Eight O'Clock Holdings, Inc., a Delaware corporation ("Holdings"), and, together with Parent and EOC, collectively "Grantors" and individually each a "Grantor") entered into that certain Trademark Security Agreement dated as of December 11, 2006 (the "Trademark Security Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreement), pursuant to which Grantors granted a security interest to Administrative Agent in, and a collateral assignment to Lender of, among other things, Trademarks, including the Trademarks set forth on Schedule 1 hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 12, 2006 at Reel 3442, Frame 650;

WHEREAS, the obligations underlying the security interest and collateral assignment are no longer owed, and Administrative Agent no longer has any interest in the Trademarks and the other collateral described in the Trademark Security Agreement; and


WHEREAS, Grantors have requested Administrative Agent release its lien on the Trademarks and the other collateral described in the Trademark Security Agreement and reassign the same to Grantors.


