RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (“Release”) makes reference to that certain Junior Subordination Agreement (“ACS Junior Subordination Agreement”) dated August 29, 2003, as amended, by and among (i) American Capital Financial Services, Inc., a Delaware corporation, as agent for the ACS Junior Subordinated Noteholders (as defined below) (“Agent”), (ii) American Capital Strategies, Ltd., a Delaware corporation, as sole initial ACS Junior Subordinated Noteholder (“ACS”), (iii) Agent, as successor administrative agent (“Administrative Agent”) to the indebtedness owed by Stravina Operating Company, LLC, a Delaware limited liability company (“Company”), and (iv) Insolvency Services Group, Inc., a California corporation, as assignee for the benefit of creditors of Company (“Assignee”).

A. Definitions

1. “ACS Junior Subordinated Noteholders” are defined, collectively, as ACS and any other holder from time to time of any of the ACS Junior Subordinated Notes.
2. “ACS Junior Subordinated Notes” are defined, collectively, as the 18.5% Junior Subordinated Notes, dated August 29, 2003, and due August 29, 2011, executed by Company to the order of the ACS Junior Subordinated Noteholders in the aggregate principal amount of \$7,500,000.00, either as originally executed or as such notes may from time to time have been supplemented, modified, amended, restated or extended.

B. Release

1. This Release is executed on behalf of Agent, this 14th day of April, 2008 (the “**Effective Date**”).
2. Pursuant to that certain Asset Purchase Agreement (“APA”), dated October 16, 2007, by and among Hanover Accessories, LLC, a Delaware limited liability company (“Hanover”) and Assignee, Company’s assets (the “Assets”) were sold to Hanover.
3. Included with the Assets sold to Hanover were certain trademarks encumbered by security interests. Those security interests were granted pursuant to the ACS Junior Subordinated Notes and attached to the following trademarks (the “Encumbered Trademarks”):
