
WHEREAS, Clearsmoke Technologies, Ltd, a Malta corporation, having a place of business at The Mall Complex, Level 5, Floriana, Malta, (hereinafter "Assignee") acquired said Mark from Assignor and adopted and began use of said Mark on or about March 31, 2006 in connection with smoked frozen fish;

WHEREAS, in consideration of the sum of five dollars (\$5.00) and other good and valuable consideration, the receipt and sufficiency of which was acknowledged, Assignor ratified the sale, assignment and transfer, and sold, assigned and transferred to Assignee all of Assignor's entire right, title and interest in and to said Mark and said registration, and the goodwill of the businesses associated therewith, and the right to bring suit and recover for past infringement of said Mark, for the exclusive use and benefit of said Assignee, its successors, assigns, and legal representatives.
