**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of May 15, 2008 by **ALLIED CAPITAL CORPORATION**, as collateral agent (in such capacity, "**Agent**").

WITNESSETH:

WHEREAS, Decade Industries, Inc., a Minnesota corporation ("**Grantor**"), is a party to that certain Trademark Security Agreement, dated as of July 21, 2006 (the "**Assignment**"), pursuant to which Grantor granted a security interest to Agent in the Trademark Collateral (as defined therein) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on July 31, 2006, at Reel 003357, Frame 0944; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "**Trademark Rights**"):

(i) each Trademark and application for Trademark listed on Schedule I annexed hereto, together with all goodwill of the business connected with the use of, and symbolized by, each Trademark; and all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (x) infringement or dilution of any Trademark or (y) injury to the goodwill associated with any Trademark; and


(ii) all other Trademark Collateral.
