

AFFIDAVIT



Richard D. Nelson, Esq., as Chapter 11 Trustee of Claddagh Development Group, LLC, an Ohio limited liability company and its affiliates (collectively, the "Companies"), deposes and states on behalf of the Companies in his capacity as Chapter 11 Trustee and not individually that:

- 1. The Companies are currently debtors in the Chapter 11 bankruptcy cases captioned *In re: Claddagh Development Group, LLC*, *et al.* jointly administered under Case No. 06-33124 (the "<u>Cases</u>"), pending before the United States Bankruptcy Court for the Southern District of Ohio (the "<u>Bankruptcy Court</u>").
- 2. Richard D. Nelson, Esq. is the duly appointed Chapter 11 Trustee (the "<u>Trustee</u>") for the Companies with full authority to act on behalf of the Companies pursuant to the United States Bankruptcy Code and orders of the Bankruptcy Court.
- 3. Pursuant to a certain Asset Purchase Agreement (the "APA"), Exhibit A in the accompanying exhibits to the Affidavit of Richard D. Nelson, Trustee (the "Exhibits"), executed by the Trustee on behalf of the Companies on or about December 12, 2007, the Trustee represented and warranted that the Companies had good and marketable title to all of the Companies' Assets, as defined in the APA, including, without limitation, all Intellectual Property assets owned by or used in the Companies' business, the trademarks "Claddagh", "Claddagh Irish Pub" and "Claddagh Irish Pubs" and all other related trademarks, trade names, service marks and licenses (the "Assets").
- 4. On March 11, 2008, the Bankruptcy Court entered a final order (i) approving the APA in its entirety, (ii) determining that the Trustee has full power and authority to transfer the Assets to the purchaser identified in the APA, free and clear of all liens, claims and encumbrances without the necessity of obtaining any further consents or approvals, and (iii) authorizing the Trustee to transfer the Assets to the purchaser identified in the APA free and clear of all encumbrances, claims, liens, mortgages, security interests, restrictions, prior assignments, obligations, pledges, charges, and liabilities against the Companies or the Assets (the "Sale Order"). The Sale Order is Exhibit B in the accompanying Exhibits.
- 5. Since his appointment, the Trustee has determined that certain trademarks used by the Companies in their business and which are among the Assets that the Bankruptcy Court, pursuant to the Sale Order, has authorized the Trustee to transfer to the purchaser identified in the APA are registered with the United Stated Patent and Trademark Office erroneously in the name of Kevin Blair, an equity holder in and former officer of the Companies.

- 7. Kevin Blair has testified under oath that the trademarks described in paragraph 6 above are owned by the Companies and part of the Companies' Assets.
