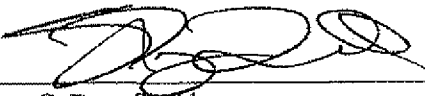

SIXTH: That a copy of the Agreement of Merger will be furnished by the surviving limited liability company on request and without cost to any member of any constituent limited liability company.

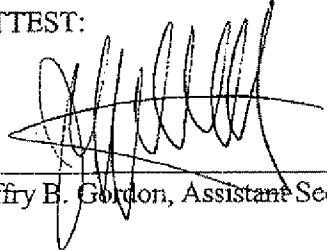
SEVENTH: The merger shall be effective upon the filing of this Certificate of Merger with the Secretary of State of Delaware.
