## TRADEMARK ASSIGNMENT

THIS ASSIGNMENT, nunc pro tunc, is made effective as of January 15, 2008, by and between Roux Laboratories, Inc., a New York Corporation, doing business as "The Colomer Group" or "Colomer" or "Colomer USA," having a principal place of business at 5344 Overmeyer Drive, Jacksonville Florida 32254, United States (Assignor), and Signature Products, Inc., an Illinois Corporation, having a principal place of business at 1765 E. 55th Street, Suite L-3, Chicago, Illinois, United States (Assignee).

WHEREAS, Assignor or its predecessor in interest has engaged in the world-wide manufacture, promotion and sale of a line of hair-care products under the product brand name "AROSCI" as a word standing alone and together with a design component, which have become trademarks/trade marks (hereinafter for convenience referred to as "the Marks") owned by Assignor; and

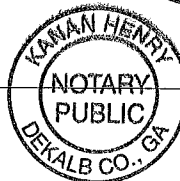
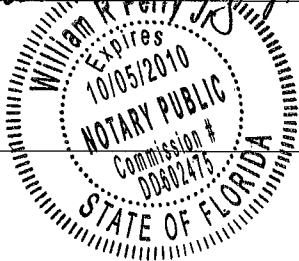
WHEREAS, Assignor and Assignee desire to provide a separate document, apart from the Asset Purchase Agreement, that confirms the assignment of the Marks as of the Effective Date, that traces the chain of title of each of the Registrations listed herein, and that may be recorded in applicable trademark/trade mark offices in lieu of the full version of the Asset Purchase Agreement; and

WHEREAS, Assignor warrants that: Assignor is the owner of the Marks in and particularly as applied to the goods listed in the certificates of registration for the Registrations for the Marks and has the right to enter into this Assignment; Assignor does not know of any prior use of any of the Marks or any third party claim of any prior use of the Marks or any confusingly similar marks on or in connection with the same or similar goods or services; there are no challenges to Assignor's ownership of the Marks or its rights to assign the Marks and the associated goodwill to Assignee; Assignor has not abandoned use of the Marks; and, either directly or through its predecessor in interest, Assignor has continuously used each of the Marks since its adoption in connection with the goods listed in the various certificates of registration in interstate commerce and/or commerce with a foreign country.

NOW, THEREFORE, in furtherance of the mutual promises and considerations exchanged in the Asset Purchase Agreement, and further in consideration of the exchange of the sum of one US dollar (US\$1.00) between the parties hereto, including good and valuable consideration, the receipt and sufficiency of all of which is hereby acknowledged and confirmed, Assignor hereby assigns, and to any extent that may be necessary confirms assignment of, sells, and transfers the Marks to Assignee together with Registrations therefor and the goodwill of the businesses associated therewith.
