**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

This TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARK RIGHTS (this "Termination and Release"), dated as of May 23, 2008 is granted by BANK OF AMERICA, N.A., a national association, as successor in interest to Fleet National Bank, located at 100 Federal Street, Boston, MA 02110 ("Releasor"), in favor of GROOVE TUBES, LLC located at 1543 Truman Street, San Fernando, CA 91340 ("Groove Tubes") as successor in interest to ALESIS LLC., a Delaware limited liability company ("Alesis").

WHEREAS, pursuant to that certain Security Agreement, dated as of August 29, 2002, made by Alesis in favor of Releasor (the "Security Agreement"), Alesis granted a security interest (the "Security Interest") to Releasor in certain of Alesis's trademarks, including those specifically listed on Exhibit A attached hereto (the "Trademark Collateral");

WHEREAS, the Security Interest was recorded in the United States Patent and Trademark Office on September 3, 2002, at Reel 2573 and Frame 0316;

WHEREAS Groove Tubes is the successor in interest and owner of the Trademark Collateral.

WHEREAS, Releasor now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Releasor hereby states as follows:

1. Release of Security Interest. Releasor hereby irrevocably terminates, releases and discharges the entirety of the Security Interest in the Trademark Collateral, and any right, title or interest Releasor may have in such Trademark Collateral shall hereby cease and become void.

2. Further Assurances. Releasor hereby agrees to duly execute, acknowledge and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

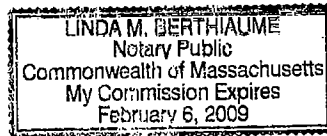
