MEMORANDUM OF SECURITY INTEREST IN TRADEMARKS

All defined terms not defined herein shall have the meanings ascribed to them in the Guaranty and Collateral Agreement.

The terms and conditions of the security interest granted hereby are contained in that certain Guaranty and Collateral Agreement dated as of May 22, 2007 among the Debtor, the Administrative Agent and the other parties thereto, as amended, supplemented, restated or otherwise modified from time to time. The security interest granted hereby is as security for Debtor's performance of Debtor's obligations identified in the Guaranty and Collateral Agreement as being secured thereby. Nothing contained in this Memorandum of Security Interest in Trademarks shall be construed as an absolute assignment of the Trademark nor as limiting any interest which Administrative Agent may have in any other collateral described in the Guaranty and Collateral Agreement or otherwise.
