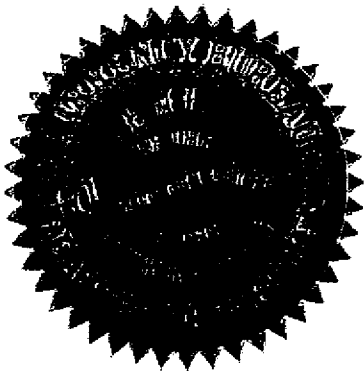
### CERTIFICATE
