AFFIDAVIT OF STEPHEN FRY

1. I am over the age of 18 years and am currently the only Director of DNI Holdings, Ltd, an Antigua corporation. ("DNI"). I have been a Director since April 15, 2008. The following facts are true based on my own personal knowledge and review of business records.

2. DNI is the true and correct owner of the trademarks attached hereto as Exhibit A (the "Trademarks").

3. On September 20, 2007, Ygraine Consultants, Inc., ("Ygraine") filed an assignment with the Assignment Services Branch assigning the Trademarks from DNI to Ygraine (the "Assignment"). The Assignment was recorded with the Assignment Services Branch at Reel/Frame 0326/098.

4. The Assignment was submitted with false and erroneous information. Tracy Barnes signed the Assignment as a Director of DNI. Tracy Barnes has never been a Director of DNI and was not authorized by DNI on March 20, 2007 to assign the Trademarks to Ygraine. A true and correct copy of DNI Directors is attached hereto as Exhibit B.

5. The true chain of title of the Trademarks is as follows: Nortech Investments Ltd. ("Nortech") was the original registrant of the Trademarks; Nortech assigned all of its right, title and interest to DNI on August 25, 2005 at Reel/Frame 3147/0465; and DNI is the current and rightful owner of the Trademarks. The chain of title for the Trademarks should not be considered altered by the incorrect Assignment.

6. Continuously since at least 2005 through the present, DNI has used and continues to use the Trademarks and continues to be the owner of the registrations of the Trademarks.

7. All statements made herein of my own knowledge are true and all statements made on information and belief are believed to be true.

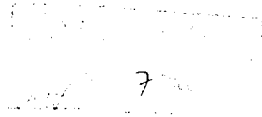
