ASSIGNMENT FOR SECURITY

(TRADEMARKS)

WHEREAS, Metalico-Granite City, Inc. and Metalico Akron, Inc. (the "Assignors") holds all right, title and interest in the trademarks listed on the annexed Schedule 1A, which trademarks are issued in the United States Patent and Trademark Office (the "Trademarks");

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Assignors do hereby assign unto the Assignee and grants to the Assignee a security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

The Assignors do hereby further acknowledge and affirm that the rights and remedies of the Assignee with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.




