GRANT OF SECURITY INTEREST

TRADEMARKS

THIS GRANT OF SECURITY INTEREST, dated as of May 30, 2008, is executed by **TRIANGLE SERVICES, INC.**, a New York corporation (the "Grantor"), in favor of **STERLING NATIONAL BANK**, as the secured party (in such capacity, the "Secured Party").

WHEREAS, pursuant to that certain Amended and Restated Credit Agreement, dated as of May 30, 2008 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among the Grantor and the other Borrowers (as defined in the Credit Agreement), as borrower, and the Secured Party, as lender, the Secured Party has agreed to extend loans and other financial accommodations to the Grantor and the other Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, the Grantor has adopted, used and is using the trademarks, more particularly described on Schedule 1 annexed hereto and made a part hereof, which trademarks are registered in the United States Patent and Trademark Office (collectively, the "Trademarks");

WHEREAS, the Grantor and other entities party thereto from time to time have entered into that certain Pledge and Security Agreement, dated as of May 30, 2008 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), in favor of the Secured Party; and

WHEREAS, pursuant to the Security Agreement, the Grantor has granted to the Secured Party a security interest in all right, title and interest of the Grantor in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the customer lists and records related to the Trademarks and the applications and registrations thereof, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement).

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Grantor does hereby further grant to the Secured Party a security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Secured Party with respect to the security interest in the Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

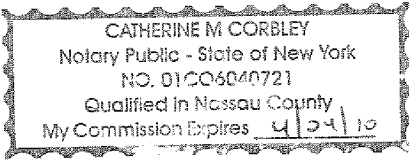
