U.S. TRADEMARK ASSIGNMENT



WHEREAS, Assignor is the owner of all right, title and interest in and to the trademarks, applications, registrations and related goodwill identified on Schedule A hereto;


WHEREAS, the Assignee wishes to acquire the trademarks, applications, registrations and related goodwill identified on the attached Schedule A;

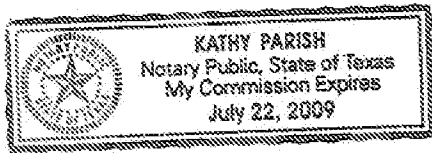
