WHEREAS, Assignor is the owner of the following trademark application which is now pending with the United States Patent & Trademark Office (the "Mark"):





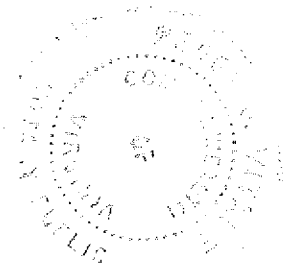
