Reference is made to (i) the Credit Agreement, dated as of April 16, 2007 (as amended by the First Amendment to Credit Agreement, dated as of October 24, 2007, and as otherwise amended, restated or otherwise modified from time to time, the "**Credit Agreement**"), among, inter alia, MacDermid Holdings, LLC, a Delaware limited liability company, Matrix Acquisition Corp., a Connecticut corporation, and MacDermid, Incorporated, a Connecticut corporation (as successor to Matrix Acquisition Corp., the "**Borrower**"), the lenders from time to time parties thereto and Credit Suisse, as administrative agent and as collateral agent, (ii) the Pledge and Security Agreement (as amended, restated or otherwise modified from time to time, the "**Pledge and Security Agreement**") dated as of April 12, 2007, made by each of the signatories thereto other than the collateral agent in favor of Credit Suisse, as collateral agent for the lenders from time to time parties to the Credit Agreement and the other secured parties delivered to the undersigned in its capacity as the administrative and collateral agent under the Credit Agreement (as such, the "**Agent**"), and (iii) the Stock and Asset Purchase Agreement, dated as of March 18, 2008 (as amended, restated or otherwise modified from time to time, the "**Purchase Agreement**"), by and between the Borrower and certain of its Subsidiaries and Trelleborg AB (publ) and certain of its subsidiaries (collectively, the "**Buyer**").

Capitalized terms used herein that are defined in the Credit Agreement, the Pledge and Security Agreement, or the Purchase Agreement and not otherwise defined herein have the meanings given in the Credit Agreement, the Pledge and Security Agreement, or the Purchase Agreement, respectively.

WHEREAS, pursuant to the Purchase Agreement, the Borrower intends to sell (and cause certain of its Subsidiaries to sell) to the Buyer all of the assets and certain liabilities related to its offset printing business;

WHEREAS, pursuant to the Pledge and Security Agreement entered into in connection with the Credit Agreement, security interests in the Released Collateral (as defined below) were granted to the Agent (for and on behalf of the Secured Parties) by the respective grantors named therein; and

WHEREAS, the Agent has been notified by the Borrower that the transactions contemplated by the Purchase Agreement are permitted under the Credit Agreement, and the Borrower has requested that the Agent (for and on behalf of the Secured Parties) authorize the disposition of the Released Collateral and confirm the release and discharge of the Security Interests in the Released Collateral upon the consummation of the sale of the Released Collateral contemplated by the Purchase Agreement and the receipt of the net proceeds thereof by the Borrower.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. *Release.* Upon satisfaction of the terms and conditions set forth in paragraph 2 below, the undersigned as Agent hereby (i) consents, without recourse, to the disposition of (x) the collateral described on Schedule 1 hereto (the "**Printing Collateral**"), (y) the collateral described on Schedule 2 hereto (the "**Borrower Collateral**"), and (z) all intellectual property collateral owned or licensed by the Borrower and the Subsidiary Guarantors used solely in connection with and related solely to the conduct of the Offset Printing Business (as defined in Schedule 1 hereto) of the Borrower and the Subsidiary Guarantors, including without limitation, the patents and trademark described on Schedule 3 hereto (the "**IP Collateral**"), and together with the Printing Collateral and Borrower Collateral, the "**Released Collateral**") and (ii) releases, without recourse, absolutely, unconditionally, irrevocably and forever, all security interests in the Released Collateral (the security interests of the Agent in the Released Collateral collectively, the "**Security Interests**") and agrees that all of the Security Interests will be, and hereby are, forever discharged.

2. *Terms and Conditions of Release.* The consent and release set forth in paragraph 1 above is given and will be effective only upon the disposition of the Released Collateral by the Borrower and/or any of its Subsidiaries to the Buyer under the Purchase Agreement and upon the receipt of the net proceeds thereof by the Borrower. The release set forth in paragraph 1 above (a) is a quitclaim release of any and all of the Security Interests insofar as they attach to any Released Collateral and (b) is given and will be effective as of the date hereof without any recourse to the undersigned (whether as Agent or in its personal capacity) and without any statement, representation, warranty, promise or undertaking whatsoever by the undersigned (whether as Agent or in its personal capacity). No obligation secured by the Security Interests is released, discharged or terminated hereby.

3. *Partial Releases.* The undersigned as Agent hereby authorizes you (or any person or entity designated by you as your delegate for this purpose) to file the UCC-3 partial releases with respect to the Released Collateral in the form as attached hereto as Schedule 4.


4. *Further Lien Releases.* The undersigned as Agent agrees that if you at any time determine and notify the undersigned as Agent in writing that the delivery of any additional instrument executed by the undersigned as Agent is required to release, discharge or terminate (a) any Security Interest, (b) any other Lien (as defined in the Credit Agreement) on the Released Collateral securing the payment of obligations under the Credit Agreement (not including any cash collateral deposit securing letter of credit obligations) granted to the undersigned as Agent pursuant to any security agreement, mortgage, deed of trust, deed to secure debt, collateral assignment or other grant of security (an "**Other Lien**") or (c) any notice, filing or registration of any Security Interest or Other Lien, the undersigned will, at your expense and as reasonably requested by you in such notice, execute and deliver (and if requested acknowledge) such other instruments effecting or confirming the release, discharge or termination of any Security Interest or Other Lien or any notice, filing or registration of any Security Interest or Other Lien on the terms set forth in paragraph 2 and otherwise in form and substance reasonably satisfactory to the undersigned.

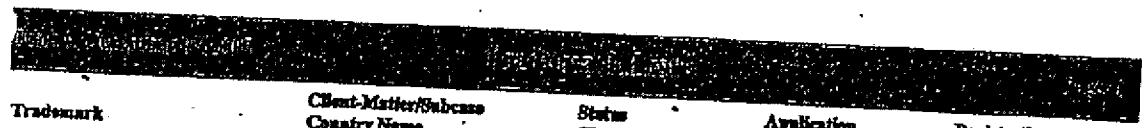
