WHEREAS, Assignor holds all right, title and interest in and to the trademarks, service marks and trade names identified in the attached Schedule A, and all applications and registrations pertaining thereto, and all common law rights associated therewith, together with all goodwill arising from the use of and symbolized by said marks, all such rights existing in any jurisdiction (collectively, the "Marks");

WHEREAS, Assignor and Assignee are parties to that certain Stock and Asset Purchase Agreement, dated as of April 18, 2008 (the "Purchase Agreement"), pursuant to which Assignor has agree to sell, assign, convey, transfer and deliver to Assignee or its assigns all of its right, title and interest in and to the Aleri Intellectual Property (as defined in the Purchase Agreement), including, without limitation, the Marks;

Assignor does hereby sell, assign, convey, transfer and deliver unto Assignee, its successors, assigns, and legal representatives, Assignor's entire right, title and interest in and to the Marks throughout the world (including any common law rights that may exist and are associated therewith), together with the goodwill of the business symbolized thereby and appurtenant thereto, the right to conduct business under the Marks, including the right to license to others under the Marks the portion of the Business (as defined in the Purchase Agreement) to which such Marks pertain, the same to be held and enjoyed by Assignee, its successors, permitted assigns or legal representatives, together with income, royalties, damages or payments due on or after the date hereof, including, without limitation, all claims for damages or payments by reason of infringement or unauthorized use of the Marks, along with the right to sue for past infringements and collect same for Assignee's sole use and enjoyment.

Assignor hereby agrees to execute such additional documents as Assignee may request to register and otherwise give full effect to and perfect the rights of Assignee under this Assignment in and to the Marks worldwide. Assignor authorizes the Director of the United States Patent & Trademark Office, and any official of any country or countries foreign to the United States with respect to any equivalent foreign rights in the Marks, to record the Marks and title thereto as the

property of Assignee, its successors, legal representatives and assigns in accordance with the terms of this Assignment.

This Assignment may be executed in counterparts (including, by facsimile), each of which will be deemed an original, but both of which together will constitute one and the same instrument.

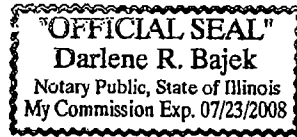
