This Agreement is made the 1st day of April 2005

**Between**

- (1) **BP p.l.c. (formerly known as The British Petroleum Company p.l.c.)** a company incorporated in England with registered number 00102498, whose registered office is at 1 St. James's Square, London, SW1Y 4PD (the "**Assignor**"); and
- (2) **O&D Trading Limited**, a company incorporated in England with registered number 05310655, whose registered office is at Chertsey Road, Sunbury on Thames, Middlesex, TW16 7BP (the "**Assignee**").

**Whereas:**

- (A) The Assignor is the owner of the Trade Marks.
- (B) The Assignor has agreed to assign to the Assignee all of its rights, title and interest in and to the Trade Marks upon the terms set out in this Agreement.

It is agreed as follows:

**1 Definitions**

In this Agreement, "**Trade Marks**" means the registered trade marks and applications for registration listed in the Schedule to this Agreement, together with the goodwill of the business in the products for which, and to the extent only that, such trade marks are used.

**2 Assignment**

In consideration of the sum of ten euros (10€), receipt of which is acknowledged, the Assignor hereby assigns to the Assignee all of its rights, title and interest in and to the Trade Marks, including without limitation:

- 2.1 all rights of action, powers and benefits in respect of the Trade Marks; and
- 2.2 the right to seek and recover damages and all other remedies for any past infringement of the Trade Marks.

**3 Further Assurance**

The Assignor shall, at its own expense, execute all documents and do all such acts and things as may be reasonably requested by the Assignee in order to give legal effect to the assignment of the Trade Marks to the Assignee.


**4 Governing Law and Jurisdiction**


