CONFIRMATORY TRADEMARK ASSIGNMENT

This is confirmation of an assignment that occurred effective August 22, 2006, (the "Effective Date") through acquisition of assets of David Landay, an individual, with an address of 26510 Rookery Lake Drive, Bonita Springs, Florida 34134, by Hopeway Group Limited, a British Virgin Islands corporation with an address of c/o Bang-Yen Lin, No. 91 Kan-Ho Rd. WHEREAS, David Landay, ("Assignor"), as of the Effective Date, had adopted used, and was using the trademark, FORSTER in relation to certain goods, including those in International Class 28 which are the subject of U.S. Trademark Registration No. 1,513,348, issued November 22, 1988, (hereinafter, the "Mark"); and

WHEREAS, Hopeway Group Limited, ("Assignee"), was desirous of acquiring and did acquire, as of the Effective Date, the Mark, the registration thereof and all associated goodwill to the extent owned by David Landay, as well as other assets of David Landay.

NOW, therefore, the Assignor hereby confirms that for good and valuable consideration, receipt and sufficiency of which are acknowledged, as of the Effective Date, the Assignor assigned to Assignee, all its right, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark and the identified registration and application for registration of the Mark as set forth above, and all rights in and to damages or profits, due or to become due, accrued or to accrue, arising out of past, present, or future infringement and misappropriations of the Mark, or injury to said goodwill, together with the right to sue or recover the same in the name of Assignee.

This Assignment shall be governed according to the laws and in the state and federal courts of the State of Florida.
