INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement Dated April 4, 2008 is between **NORTHERN TRUST, NA** ("Bank") and **CSRSI, Inc.** ("Grantor").

RECITALS


- A. Bank will make advances to Grantor ("Loans") as described in the Loan and Security Agreement (the "Loan Agreement"), but only if Grantor grants Bank a security interest in its Copyrights, Trademarks, Patents, and Mask Works.
- B. Grantor has granted Bank a security interest in all of its right, title and interest, presently existing or later acquired to all the Collateral.

AGREEMENT

Grantor grants Bank a security interest in all of its right, title and interest in its Intellectual Property Collateral (such as the Copyrights, Patents, Trademarks and Mask Works listed on Schedules A, B, C, and D), and all proceeds (such as license royalties and proceeds of infringement suites), the right to sue for past, present and future infringements rights throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part.



Bank's exercise its rights, powers or remedies in this agreement, the Loan Agreement or any other Loan Documents, does not preclude the simultaneous or later exercise of any or all other right, power or remedy.


