TRADEMARK ASSIGNMENT

Effective Date: May 14, 2008

THIS TRADEMARK ASSIGNMENT (this "Trademark Assignment"), dated as of May 13, 2008, is made by and among NORMENT SECURITY GROUP, INC., a Delaware corporation ("Assignor"), COMPUDYNE CORPORATION, a Nevada corporation ("CompuDyne"), and NORSHIELD CORPORATION, an Alabama corporation ("Assignee").

WHEREAS, Assignor has adopted, acquired, used and is using exclusively in its business the following mark registered with the United States Patent and Trademark Office (the "Mark"):

- 78-679940 NORSHIELD (Block letters) - Registered, International 9; and

WHEREAS, Assignee is desirous of acquiring all right, title and interest in and to the Mark, and Assignor wishes to transfer, convey and assign all right, title and interest in and to the Mark to Assignee (the "Transfer");

WHEREAS, the Transfer is occurring pursuant to that certain Separation Agreement, to be dated on or about May 14, 2008 (the "Separation Agreement"), by and among Assignor, Assignee, Gores Patriot Holdings, Inc., and CompuDyne, and subject to and in accordance with the terms and conditions set forth therein, Assignor has agreed, among other things, to transfer to Assignee the Mark;

WHEREAS, in accordance with the other terms of the Separation Agreement, the Transfer will occur as a dividend by Assignor of the Mark to CompuDyne and CompuDyne's immediate assignment of the Mark to Assignee;

NOW THEREFORE, Assignor does hereby assign via a dividend unto CompuDyne, and CompuDyne does hereby assign unto Assignee, its successors and assigns, all of such party's right, title and interest in and to the Mark and the registration thereof, together with all the goodwill of the business connected with the use of and symbolized by the Mark, and together with any and all interests, claims and rights, including the right to sue and collect damages and/or profits for past infringements of the Mark, the intent hereof being to substitute CompuDyne in

the place of Assignor and immediately thereafter to substitute Assignee in the place of CompuDyne.

Assignor and CompuDyne authorize the Commissioner for Trademarks of the United States, Patent and Trademark Office or such other person or entity whose duty it is to record trademark registrations, applications and title thereto and/or assignments thereof, to record the Mark and title thereto as the property of Assignee, its successors, legal representatives and assigns in accordance with the terms of this Trademark Assignment. Assignor and CompuDyne further agree to perform all reasonable and proper additional acts and to execute such further documents or instruments as may be reasonably required to record Assignee as the owner of the Mark and registration herein assigned.

The validity and construction of this Trademark Assignment shall be governed by the laws of the State of New York without regard to the conflicts of laws principles thereof.
