TRADEMARK SALE AND ASSIGNMENT AGREEMENT

Trademark ODYSSEA
REG. 3,087,089 Int. Cl.: 16, REG. 3,125,486 Int. Cl.: 7 and 11

The agreement was made as of the 4th day of April, 2008 by and between eSealife, Inc., (formerly Aqualogics, Inc.), a Texas corporation, having its principal place of business at 4647 Pine Timbers St., Ste 120, Houston, TX 77041 (or "the Seller"), and Wei Guang Sheng, residing at C16 Longxi Rd., Liwan District, Flower Exposition Park, Guangzhou, Guangdong, China (or "the Buyer").

The Buyer desires to purchase, and the Seller desires to sell, all of the Seller's rights, title, and interests in and to the Odyssea trademarks bearing Registration No. 3,087,089, Int. Cl.: 16 and 3,125,486 Int. Cl.: 7 and 11 (or collectively the "Trademarks"). The Buyer acquires all of the goodwill of the Seller exclusively to the Trademarks.

The parties hereby agree to the following:

- The Buyer acknowledges that no legal advice of any kinds will be offered by the Seller. It is the responsibility of the Buyer to seek legal advice from a certified and/or licensed attorney.
- The Buyer agrees that the Trademarks are sold on an "AS-IS" basis. No refunds, exchanges, or returns will be accepted by the Seller after the transfer.
- The Buyer acknowledges that each Registration bears a certain class(es) and owning the Trademarks does not entitle protection beyond the realm of each registered class.
- The Buyer acknowledges that as between the Seller and the Buyer, Buyer owns the Trademarks and that the Seller has no rights, titles, or interests in the Buyer's Trademarks.
- The Buyer agrees that any activities, whether legal, illegal, intentional, or unintentional, conducted after the sale of the Trademark are the Buyer's full responsibility. The Seller will not be liable for any results or consequences of any kinds after the transfer of the Trademarks.
- The Buyer agrees never to sue the Seller and it's officers, present or future, for any direct, indirect, special, punitive, exemplary, or consequential damages (including but not limited to damages for lost revenue, lost profits, business interruption, property damage, and the like) arising from the usage or misuse of the Trademarks.
- The agreed payment terms and method must be met prior to the exchange. Failure to forward payment within the agreed period of time will terminate this entire agreement. Payment may be made in the form of cash, cashier's check, or wire transfers.
- The Seller may only conduct commerce with the usage of the Trademarks under the consent of the Buyer and/or any future owner(s) of the Trademark.
