ASSIGNMENT OF SECOND LIEN TRADEMARK SECURITY AGREEMENT

This ASSIGNMENT OF SECOND LIEN TRADEMARK SECURITY AGREEMENT dated as of April 18, 2008 (the "Assignment") is made by CIT Lending Services Corporation, as Administrative Agent for the benefit of Secured Party, with an office at 44 Whippány Road, Morristown, NJ 07960 (the "Assignor"), in favor of Wayzata Investment Partners LLC, with an office at 700 East Lake Street, Suite 300, Wayzata, MN 55391, Attn: Steven M. Adams, as Administrative Agent (the "Assignee").

WHEREAS, the Assignor is the Secured Party pursuant to a Second Lien Trademark Security Agreement dated July 31, 2006 (the "Agreement") by Legends Gaming, LLC, a Delaware limited liability company (the "Grantor") in favor of Assignor, as to the trademark collateral described below;

WHEREAS, the Agreement covers certain trademarks, trade names, trade styles and service marks, including those trademarks and registrations listed on Schedule 1 attached hereto, which Agreement was recorded on September 1, 2006, at Trademark Reel 3382, Frame 0692, in the United States Patent and Trademark Office;

WHEREAS, the Assignor desires to assign to the Assignee, among other things, all of its estates, properties, rights, powers, duties and trusts under the Agreement in its capacity as Administrative Agent for the benefit of Secured Party, including its right, title and interest in and to the Agreement in its capacity as Administrative Agent, and in furtherance thereof, the Assignor has agreed to execute and deliver to the Assignee this Assignment. Terms used and not defined herein shall have the meanings given to them in the Agreement.

NOW THEREFORE, FOR VALUE RECEIVED, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby transfers, assigns, sets over and delivers unto the Assignee, its successors and assigns, and the Assignee hereby accepts, 100% of the right, title and interest in the Agreement as Administrative Agent for the benefit of Secured Party, including, without limitation, all moneys and claims for moneys due and to become due from Grantor under and pursuant to the Agreement, all of Assignor's right, title and interest, powers, remedies and privileges under the Agreement, and all claims for damages arising out of any breach of the terms of the Agreement.

IN WITNESS WHEREOF, the undersigned has caused this Assignment of Second Lien Trademark Security Agreement to be duly executed as of the date first written above.
