## ASSIGNMENT

(hereinafter "Assignee"), is desirous of acquiring said registrations and applications for registration, as well as the entire right, title, and interest of Assignor in and to (i) the Marks, (ii) all other registrations and applications for

registration (if any) of the Marks, (iii) all goodwill evidenced by the Marks, (iv) all renewals and extensions that may be granted in respect of any of said registrations or applications for registration, and (v) the License; and

WHEREAS, Assignee desires to assume the obligations of Assignor under the License; and

WHEREAS, Assignor desires to make such assignment to Assignee, and to allow Assignee to assume such obligations;



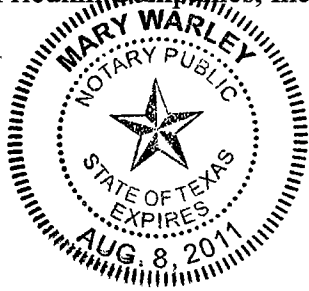

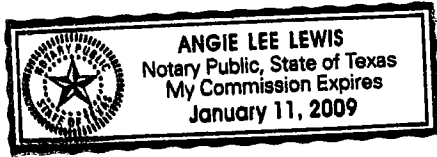
