WHEREAS, Assignee is desirous of acquiring the entire right, title and interest in and to, and all good will associated with, the Registrations;


WHEREAS, Assignor is desirous of transferring to Assignee its entire right, title and interest in and to, and all good will associated with, the Registrations;


