This TRADEMARK ASSIGNMENT, *nunc pro tunc* as of ~~April~~ ^{June} 6, 2008, is made by and between Planet Salvage, Inc., a Delaware Corporation, with its principal place of business at 13324 W. 98th St., Lenexa, Kansas, United States of America ("Assignor") and PS Holdings, L.L.C., a Kansas Limited Liability Company, with its principal place of business at 8400 W. 110th St., Suite 130, Overland Park, Kansas, United States of America ("Assignee").

WHEREAS, Assignor is the owner of the United States Trademark Registration 2583096 for "PLANET SALVAGE", registered on June 18, 2002, and the goodwill of the business symbolized thereby and associated therewith (the foregoing collectively referred to as the "Mark");

WHEREAS, Assignee is desirous of acquiring the Mark, and of recording its status as owner of the entire right, title and interest in and to the Mark;

WHEREAS, pursuant to and as set forth in that certain Asset Transfer Agreement between Assignor and Assignee dated September 2, 2002, Assignor assigns the Mark, the registration thereof and the goodwill associated therewith to Assignee;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:



Assignor does hereby assign, transfer and convey to Assignee *nunc pro tunc* effective as of September 2, 2002, all its right, title and interest in and to the Mark, inclusive of the goodwill of the business symbolized by the Mark and the right to recover and have damages and profits for past infringements, if any.

2. Assignor agrees to take whatever further action is deemed necessary or appropriate by Assignee to properly and fully effect and perfect the transfer to Assignee of the Mark, including without limitation to execute assignments to Assignee regarding the Mark as may be required in proceedings throughout the world.

3. This Trademark Assignment shall be governed by the internal laws of the State of Missouri, without reference to its conflicts of law principles.

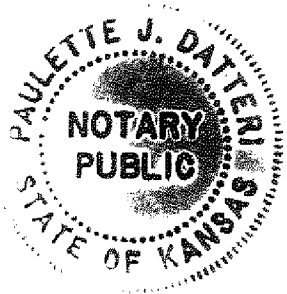
